

MINUTES OF THE DDC MEETING HELD ON 05.09.2018 AT 11.00 AM IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Smt. Banashree Nath, ACS, District Commissioner, Dhubri. She welcomed all the Officials present in the meeting and requested SPO, to read out the minutes Department wise. The house then reviewed the progress of schemes implemented by different departments as per agenda.

**1. DI & CC:-**

The Asstt. Manager, DI & CC Gauripur, briefed the progress of different schemes implemented by the DI & CC as follows :-

Name of the Scheme	Target	Achievement

The Asstt. Manager, DI & CC, Gauripur informed that they have received 215 nos. of applications online till date and the last date of submission of online application is 31<sup>st</sup> August 2018. The Chairman requested LDM, Dhubri to direct all banks to take initiative for achieving the target given to them without fail.

The Asstt. Manager, DI & CC, Gauripur in reply to the question, informed that the list of applications under PMEGP submitted to Private Banks during last financial year along with status report will be submitted soon.

- i) Boneej :- It was reported that due to non-availability of margin money the proposals are yet to be sponsored.
- ii) SVAYEM :- The AM, DI & CC, Gauripur reported that a total of 7974 nos. of applications have been received till date against the target 4469 nos. and the same is under process of scrutiny. The last date for submission of form under the scheme has been fixed on 12 August' 2018.

**2. TOWN & COUNTRY PLANNING:**

The Deputy Director briefed the house on the implementation of different schemes under his department in the district. The Deputy Director informed that total targeted beneficiaries are 9486 Nos. under PMAY-HFU and FTO send to State is 2147 Nos.in the district.

As per MIS a total of 1743 Nos. beneficiaries under M.B, Dhubri has received fund for PMAY-HFU ( 1<sup>st</sup> Phase). Similarly 298 nos. of FTO has been generated for Gauripur TC (1<sup>st</sup> Phase) and sent to State. However, no fund has been released by the State.

The DDC, Dhubri requested Dy. Director, T&CP, Dhubri to submit scheme wise report henceforth.

Regarding permission of building construction in MB areas , the Dy. Director, T&CP, Dhubri informed that the Dhubri Municipal Board is still issuing building permission from their own end without taking recommendation from the Town Planning Authority. The Chairperson directed him to inform Deputy Commissioner, Dhubri in detail accordingly.

Regarding providing Contingency fund under PMAY-HFU, the Dy. Director, T&CP, Dhubri informed that he has not received any letter in this regard from EO. MB, Dhubri for which he couldn't move M.D, PMAY-HFU.

**3. WATER RESOURCE:-**

The E.E. Water Resource Dhubri informed that 4 (four) nos. of works under FMP schemes have been completed up to 70% to 75%. The balance works could not be done because of non-receipt of Central Funds till date.

**4. PWD (R/R):-**

The EE, PWD (R/R), Dhubri submitted scheme wise detail report with contractor's name for proper analysis. The meeting reviewed the progress of road schemes under Dhubri district. The E.E, PWD (R/R), Dhubri was asked to keep ready all documents for Department wise review meeting to be held shortly.
