2. Regular visit to FCI Depot, Wholesale Co-operatives, GPSS to detect possible diversion of allotted PDS/TPDS articles and check their qualities and take appropriate action against the defaulters.
3. Regular visit to New Ghat, Panchu Ghat and other ghat of Dhubri town areas to check and detect illegal movement of any PDS/TPDS articles to riverine areas and take appropriate action against the defaulters including lodging of FIR with police station.
4. Regular checking in all Petroleum Oil Depots and S.K.Oil Depots in all urban and rural areas of Dhubri Sub-Division to detect possible adulteration and take appropriate action against the involved Firm/Person.
5. Drawing of sample from the available stock of Petroleum Oil Depots and S.K.Oil Depots and submit report to this office along with the samples for obtaining analysis report from the competent authority on regular basis.
6. Regular checking in all LPG distributors, hotels,restaurant,dhabas etc. in all urban and rural areas of Dhubri Sub-Division to detect possible diversion of LPG and take appropriate action against the involved Firm/Person.
7. Keep vigil and check on price/stock of essential commodities in the open market.
8. Fortnightly Returns/Reports in the above matter is to be submitted to this office for onwards submission to Govt. on regular basis.

ORDER

It has come to the notice of authority that there is lack of regular supervision/Inspection of PDS commodities by Area Officer of FCS&CA Dhubri in spite of standing govt. instruction in this regard which have been reiterated with issue of specific orders from time to time

Henceforth, all Inspectors/ Sub-Inspectors of FCS&CA Dhubri will ensure lifting, arrival and distribution of all monthly allotment of PDS commodities by PDS nominees for their respective jurisdiction/area and submit report with signature of 5(five) F I card holders on rotation basis about proper distribution as per following format by 30th of every month so as to enable the authority to make sub allotment to such PDS nominees for next month based on such report. In case of GPSS such signature may be obtained from FIC holders against the Agent of the concern GPSS on rotation basis.(Both Agent and FIC holders on rotation).

The report should be submitted separately for each GPSS/F P Shop.
